Status & Accomplishments 2020/21

- 2021 Another on-line year / with very few exceptions
- Governance remains unchanged as of November 2021
- A key objective from the GA 2020 was use 2021 HPCevents with in-person to promote EOFS. But ISC 2021 was on-line only and European in-person presence at SC 21 was minimal.
- BeeGFS and LUSTRE BoF turnout at ISC 2021 and SC'21 was quite good – over 100 attendees (peak) at all sessions
- Also more than 100 at the DAOS User Group "DUG"
- But: Several members are late/behind with their EOFS annual contribution. EOFS is (again / still) in black numbers



Status & Accomplishments 2020/21

 Meeting with the head of DKRZ in Hamburg (Prof. Thomas Ludwig) to discuss future LUSTRE-related activities ahead of ISC. DKRZ has one of the largest German LUSTRE installations and is willing to host related events.

Note: ISC 2022 will take place in Hamburg from May 29th – June 2nd

- EOFS update/lecture at HPC Cetraro (Italy) Conference 2021 with the opportunity to talk to several HPC executives.
- Microsoft has officially joined EOFS on September 2, 2021
- NVIDIA has officially declared to become a member of EOFS
- As always big kudos to Julian Kunkel for keeping the EOFS website up-to-date. But additional work is needed







DAOS Ecosystem


